**1. INFORMATION THAT WE COLLECT**

We may collect the following information from you when you use our Products and/or Services. The information so collected may be stored on our servers.

a. **Account Information.** When you register to use the Products and/or Services or when you create an Account, we may collect all the information that you provide at the time of creating/registering such an Account. This may include personally identifiable information, which is any information that can individually identify you and includes, among other things, your name, e-mail address, telephone number, postal address, credit card, billing and contact information. We may also collect information that does not personally identify you such as your location, demographics and/or the usage extent of your Products and the Internet.

b. **Usage of Products.** We collect information pertaining to the IP address determine your geolocation when you use our Products.

c. **Payment Information.** When you make payments through our Site or our Mobile App, you may need to provide your shipping address and financial account information, such as your credits card number, to our payment processing partner. We do not collect or store financial account information, though we may receive transaction identifiers and summary information that does not include credit cards or bank accounts.

d. **Cookies.** When you visit or use our Site or Mobile App or open our emails, we and our third-party service providers may collect certain information by way of cookies. The information collected in this

manner includes IP address, browser characteristics, device IDs and characteristics, operating system version, language preferences, referring URLs, and information about the usage of our Site, Mobile App and Products. We may link this data to your Account. We use cookies to help remember and process payment for Products that you add to your shopping cart. Compile aggregate data about traffic on our Site and Site interactions in order to offer better experience and tools. You may be able to change browser settings or phone settings, whichever applicable, to block and delete cookies when you access the Sites through a web browser or through our Mobile App. However, if you do that, the Sites or the Mobile App may not work properly. Our ad networks and analytics service providers may also collect information about your use of other websites and online services over time, if those websites and online services also use the same service providers. We currently use Google Analytics to collect and process certain website usage data. ## 2. **HOW WE USE YOUR INFORMATION?**

### a. **We use the information that you provide to:**

- i) Process your purchase of our Products and/or Services;
- ii) Personalize your experience in using our Products and/or Services;
- iii) Provide, operate, maintain, and improve our Products and/or Services;
- iv) Enable you to access your Account;
- v) Notify you about the changes to our Site, Mobile App, Products and/or Services;
- vi) Respond to your comments, questions, and requests and provide customer support;
- vii) Monitor and analyze trends, usage, and activities in connection with our Products and/or Services;
- viii) Investigate and prevent fraudulent transactions, unauthorized access to our Products and/or Services, and other illegal activities;
- ix) Personalize and improve our Products and/or Services, and provide content, features, and/or advertisements that match your interests and preferences or otherwise customize your experience on our Sites and Mobile App;

### b. **Disclosure of information to third-party:**

We do not sell, trade, rent, or otherwise transfer personally identifiable information to others, except: (i) as provided in this Policy, (ii) to defend against legal claims or otherwise protect our rights, (ii) as required by law, judicial proceeding, court order, or legal process served on us, (iv) for purposes of law enforcement investigations, (v) to protect rights, property, or safety of our customers, and/or (vi) with your consent.

We may share or transfer your information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.

If you submit a request for information through our Sites, or the Mobile App or by any other means, you agree that we may share the information you submit with third parties, as necessary to respond to your

request. Such third parties' use or disclosure of the information you submit is subject to their privacy policies and practices and we have no control over the subsequent use or disclosure of any information you provide. If we offer functionality to share information via email or social media on any of our Sites and you choose to use such functionality, the information you provide may be shared with recipients. We may share with third parties, including but not limited to, other users and vendors: (1) information you submit in your Account, and (2) your feedback regarding our Products and/or Services. The third-party service providers that we use help us in performing various functions such as processing credit card transactions, analyzing data, serving advertisements and providing marketing assistance. All service providers are contractually required to treat personally identifiable information as confidential.

### **3. OUR COOKIE POLICY**

Cookies are small pieces of text used to store information on web browsers. Cookies are used to store and receive identifiers and other information on computers, phones, and other devices. Other technologies, including data we store on your web browser or device, identifiers associated with your device, and other software, are used for similar purposes. In this Policy, we refer to all of these technologies as "Cookies."

We use Cookies to compile data regarding user interactions with ad impressions, and other ad service functions as they relate to our Site and Mobile App. However, you can set your browser to refuse all or some browser Cookies, or to alert you when Cookies are being sent.
